## サラワク土地法2条 先住慣習地を規定 Section 2 of the Sarawak Land Code defines Native Customary Land as

(a) 先住民族の慣習的権利のある土地は、それがコミュニティレベルか否かに関わらず、1958年1月1日以前に合法と認められた土地であること。

land in which native customary rights, whether communal or otherwise, have lawfully been created prior to the 1<sup>st</sup> day of January 1958 and still subsist as such;

(b)第6条の適用により先住民族の暫定的土地利用権が認められる(1958年以降)

land from time to time comprised in a reserve to which section 6 applies; and

(c)内陸部の先住慣習地は地方政府の許可を得れば、 第10条の下で利用が合法化される(1958年以降)

Interior Area Land upon which native customary rights have been lawfully created pursuant to a permit under section 10.

# 先住民族の慣習的権利のある土地は、それがコミュニティレベルか否かに関わらず、1958年1月1日以前に合法と認められた土地であること。

Land in which native customary rights, whether communal or otherwise, have lawfully been created prior to the 1<sup>st</sup> day of January 1958 and still subsist as such.

- i. 1958年以降に先住慣習権(土地)を設定する場合、第5条の規定に従い、第10条の下で許可を得る。
- If a native claims NCR over land after 1958, it must be with a permit under section 10, as provided for under section 5 of the Code;
- ii. 先住慣習地では、コミュニティや個人が権利を主張することができる

That the said NCR over land in can be created and could be claimed either by a community or an individual; and

iii. 先住慣習地は今日まで継続している。 That the NCR Land subsists as such until today.





# What are causes? 原因は?

- 不適正/不正な手続きによる土地リース(伐採、植林)権の発行 例:コミュニティの主張を確認するための現地調査をせずに発行される リースなど
- leases issued without proper /abuses of procedures (Eg. leases issued from office without field surveys to identify claims by communities)
- 政治的意思の対立
- Conflict Political will.
- 判例や裁判所の判決がなかなか認められない
- Reluctant to recognize legal precedents or court Judgments.
- 社会との紛争に対処するための国際法(FPIC,UNDRIP,CBD等)への配慮/義 務の欠如
- no consideration/obligation of International Laws (Eg. FPIC, UNDRIP, CBD) for addressing disputes with communities
- 法律は良く、現場での施行は悪い
- Good laws, Bad implementation on the ground.
- 先住民族の慣習が尊重されない
- no respect of Native's Custom and practices of Indigenous peoples.





#### Court:

Judgment delivered as follows:

- (i) The Plaintiffs have inherited Native Customary Rights over the Bukit Bediri Forest Reserve and the Stika Forest, the boundaries of which are as delineated and show in the maps produced by the Forestry Department Sarawak and Lands and Survey Department Sarawak appearing at pages 1 and 2 of Exh. D4.
- (ii) The construction of the rail line across these tow forests constitutes an encroachment and a trespass of the land.
- (iii) The Defendants are jointly and severally liable to pay damages, to be assessed by the Deputy Registrar, to the Plaintiffs (except those from Kampung Stika) for the said trespass.

Since Counsels handling the case is not present, I would fix this case for further mention on 4.4.2011 at 9.00 a.m. for parties to address me regarding their agreement on costs.
